• Discussions were held regarding the emerging manager international search. Staff will continue due diligence on firms and provided an update at a future Investment Committee Meeting.

# **Hedge Fund Search**

- Discussions were held regarding adding an additional Hedge Fund manager(s) to the hedge fund portfolio.
- Mr. Trevino made the motion to approve a Hedge Fund Search. The motion carried unanimously.

# **Brevan Howard Investment**

- Discussions were held regarding the current investment with Brevan Howard and redeeming from the Brevan Howard Multi-Strat Fund and invest the proceeds into the Brevan Howard Master Fund.
- Mr. Reed made the motion to approve the redemption from Brevan Howard's Multi-Strat Fund and invest the proceeds to Brevan Howard's Master Fund. The motion carried unanimously.

## **Core Real Estate Search**

- Mr. Reed made the motion to approve a Core Real Estate Search. The motion carried unanimously.
