• NEPC gave an update regarding the performance of the Fund in the 3<sup>rd</sup> quarter of 2014. During this time period, the Fund generated a -1.0% return. For the 5 years ending September 30, 2014, the Fund had an annualized return of 9.04%, standard deviation of 6.99% and a Sharpe ratio of 1.28, placing the Fund in the top 15<sup>th</sup> percentile for riskadjusted performance.

### **Emerging Manager Process**

- Discussions were held regarding the Emerging Manager process. Staff, Board and Attucks Asset Management discussed the different stages of due diligence and how Staff and Board will work together with Attucks in the portfolio construction process.
- Mr. Griffin made the motion to terminate Monarch Partners and High Pointe Capital and commit the proceeds to Cooke & Bieler. The motion carried unanimously.
- Mr. Griffin made the motion to terminate Palisades Investment Partners and temporarily hold the redemption proceeds in an appropriate index fund. The motion carried unanimously.

• Mr. Griffin made the motion to approve an Emerging Manager International Equity Search. The motion carried unanimously.
